PUBLIC PARTICIPATION INFORMATION

1. Public meetings of the Board shall follow a prescribed agenda, which will be available to the general public two days preceding the meeting.
2. If members of the public wish the Board to address a specific item at a public meeting, a written request to the Township Manager shall be submitted by noon on Friday of the week before the meeting. The written request shall specify the item or items the individual desires to be addressed.
3. The Board may consider other matters for the agenda as they see fit.
4. The Board will entertain Public Comment at either the beginning of the meeting or prior to specific action items during the meeting, at the discretion of the Chair. Individuals must advise the Chair of their desire to offer such comment.
5. A Public Comment period will be provided at the conclusion of a meeting for input on any subject.
6. The Board Chair shall preside over Public Comments and may within their discretion:
 - a. Recognize individuals wishing to offer comment.
 - b. Require identification of such person.
 - c. Allocate total available Public Comment time among all individuals wishing to comment.
 - d. Allocate up to a Three (3) minute maximum for each individual to offer Public Comment at a meeting, Township Staff shall time comments and shall announce, “one minute remaining” and “time expired” to the Chair.

- e. Rule out of order scandalous, impertinent and redundant comment or any comment the discernible purpose of which is to disrupt or prevent the conduct of the business of the meeting including the questioning of, or polling of, or debating with, individual members of the Board.

MINUTES

Meeting originally set for IN-PERSON, later changed to VIRTUAL due to weekend winter weather and subsequent road conditions.

Chair Hurley called the MCAB meeting to order at 7:11 PM.

ANNOUNCEMENTS

MCAB congratulated former member Megan Griffin-Shelley on becoming Whitemarsh Township Supervisor, and MCAB's new liaison to the Board of Supervisors. Ms. Griffin-Shelley said she is glad to still be a part of the Media Advisory Board, now as a liaison.

Unfortunately, this leaves MCAB with a vacancy. Mr. Hurley asked to have this communicated with residents so that anyone interested – and who knows the types of communications the Township uses – can apply to join.

Mr. Brown acknowledged the difficulty in planning tonight's meeting prior to and during this weekend's winter storm and thanked everyone for hanging in there. Board members noted it has been a while since an MCAB meeting was held entirely via Zoom.

REORGANIZATION

Election of Chair and Vice Chair for 2026

Mr. Cratin nominated Ryan Hurley for Chair, and Sharon Harvey for Vice Chair. Ms. Harvey seconded.

Seeing no other nominations, the board unanimously (3-0) re-appointed Mr. Hurley as Chair, and Ms. Harvey as Vice Chair for 2026.

APPROVAL OF MINUTES

November 24, 2025

A motion was made by Chair Hurley, seconded by Ms. Harvey, to approve the minutes for November 24, 2025, as presented. The motion was carried unanimously (3-0).

NEW BUSINESS

1.) Preview of “America 250 in Whitemarsh” Webpage

Mr. Brown presented to the board Whitemarsh Township’s webpage on “America 250”, still in draft form. The new page, in coordination with the Parks & Recreation Department, provides tons of information and upcoming events for residents to get excited about the nation’s Semi-quintcentennial, and how they can celebrate the big event locally. The page includes national, state and County resources, as well as local events held by various historic sites, non-profits and others in Whitemarsh. Mr. Brown explained this will be a fluid page, meaning it will be updated throughout the year as new events are announced. The board liked its overall look and organization. There was a discussion about getting that communicated to the public once it’s live. Mr. Brown added it will be shown at the next Board of Supervisors Departmental Workshop meeting in early-February, and then it would go live sometime thereafter.

Roy Wilson (previous/former owner of Abolition Hall property) asked how someone can find the page on the website. Mr. Brown – again, noting it wasn’t live yet - showed him and the board how to get there from the homepage.

2.) Discussion on Potential Webpage on Abolition Hall Property

Mr. Brown explained that the Abolition Hall Steering Committee, at their January 12th meeting, brought up the idea of a special webpage devoted to the Abolition Hall property, and asked if it was better to have it on the Township Website, or create an external page linked to our website. This new page, as discussed at the time, would have lots of information about the property, a QR Code for making donations to help fund Homestead building upkeep and future programming; and anything else that comes up.

In the lengthy discussion that followed, topics included the communication aspect of promoting Abolition Hall, options for creating and maintaining external websites, and assigning roles regarding page development. Chair Hurley said creating this website could make a great project at the high school level.

Roy Wilson commented on the Township’s website, noting some items in there are difficult to find, and that people tend to look up specific information by Googling it. He added that a proposed series of short videos for the webpage – also discussed at the Steering Committee’s meeting – is in the works, with him developing scripts, and eventually working with Mr. Brown to record and edit them together. Mr. Brown said he looks forward to working with him on that.

On the question of using the Township website or a standalone page, the board agreed the latter option would work better, while providing a link to said page on the Township Website. Additionally, the board requested communication of this feedback to Township staff and the Abolition Hall Steering Committee.

3.) Infographic Rotation Summary (Government Access Channel):

Mr. Brown provided a summary of notable additions and updates to the infographic slideshow rotation on Whitemarsh Community Access (the cable channel) and showed a PowerPoint with the infographics themselves. The board found the visual presentation helpful in the discussion.

Chair Hurley asked about one of the slides (“Revolutionary Women: Writing During War,” January 29th at the Library), and how one would know – if on social media – if it was an

upcoming event, or to get more information on it. He also said the QR Code is a nice touch, as it allows quick access to more information.

No questions from the board. Chair Hurley said he likes the 60-second videos but added it takes more effort to reduce them to that length.

 - Script segments fully completed and reviewed. Two of six (as-yet-unproduced) segments voiced over. A seventh segment will be the completed "Whitemarsh Authority" promo, completed 2025.
- **Preparing for Winter Storms: Transition to Winter Operations**
 - Proposed by the Public Works Department in November/December, but only some pre-production work done so far. Some B-roll showing the transition in action shot in December.
- **Planned Video Promos:**
 - WJML Used Book Sale
 - Whitemarsh Living & Digital Archive (*access to previous Whitemarsh Livings*)
 - 2026 Trash Mob events
 - "America 250" in Whitemarsh

Subject: Abolition Hall Communication Projects Update
Date: March 17, 2026

Included in your March 23rd packet is a summary of ongoing discussions to-date by the Abolition Hall Steering Committee (AHSC) on ideas to promote the Abolition Hall/Corson Homestead property (4006 Butler Pike & 1 Germantown Pike), as the Committee find ways to reactivate the three main buildings from residential to a public institutional/educational site and accessible open space area. A representative from the Steering Committee is scheduled to appear to update MCAB on at least three (3) communication or promotional project ideas, all detailed below. MCAB would likely continue providing feedback on their projects, while I will play an active role in them as the Township's "behind-the-scenes" video person:

- **Abolition Hall Webpage/Website:** MCAB provided input on the Committee's website vs. webpage debate in January, either of which would promote the Abolition Hall property. Specifically, the new website would include the history of the buildings and adjacent fields, opportunities for tours, photos, and other items, and a QR Code for donations to help cover the cost of building maintenance and future programming. MCAB's feedback went to the AHSC on March 2nd (memo provided for reference). On March 16, a new page on the Township website went live, accessible from the "Community" dropdown menu - a first step towards eventual creation of an external website. Additional information for the webpage is forthcoming.
- **Abolition Hall Video Series:** Scripts continue to be worked on for this planned series of short videos that discuss the site's historical significance, building architecture, and more, all for the new Abolition Hall webpage/website once up and running. Each video segment would feature Roy Wilson, addressing each of the topics. No production timeline established yet, as of this writing.
- **Video-Recorded Site Tour:** An art student from Montgomery County Community College interested in the works of Martha Maulsby-Hovenden – the daughter of painters Thomas Hovenden and Helen Corson-Hovenden – is scheduled to go on a tour of the site's three buildings, led by Mr. Wilson. The student will also be writing a blog post about Ms. Maulsby-Hovenden's sculpting work and career. Both items would appear (the blog post with permission) on the Abolition Hall page once active.

The Media Communications Advisory Board (MCAB), at their January 26th meeting, provided their input and feedback on whether a webpage on the Abolition Hall property – first debated during the January 12th meeting of the Abolition Hall Steering Committee – should be on the Township’s website or its own website. Roy Wilson, from the public, was in attendance and was interested in hearing MCAB’s thoughts on the question. A summary of the discussion follows:

- The board looked at this from multiple perspectives. The first was getting people interested in the property and its unique nature by organizing and presenting information about the site, history, future events, donation buttons/links, etc. Also, having said website visually communicate the property’s significance, and creating an awareness of its public accessibility. Comments regarding the Township Website pointed to how some informational topics are difficult to find, page formatting, and that lookup of online information is often done using Google or similar search engines.
- Marketing was another key point – thinking about the website’s domain name (i.e.,: “www.abolitionhall.org”); strong, overall site branding, and spreading the word about the page – such as our Electronic Community Sign and a link to the page on the Township’s website.
- External Web Design: In addition to web designer-based services, the MCAB board also noted platforms where websites can be easily built with existing, pre-made templates. Many (if not most) of these options – such as Wix and Squarespace – cost little to nothing to build and maintain said website. Another option mentioned was to have it done at the high school level, perhaps even locally.

Therefore, the MCAB board made the following recommendations to the Steering Committee:

- The Abolition Hall webpage (if given the green light) should be **EXTERNAL**, and place a link to said external page on the Township’s website.
- Suggest reaching out to folks who are experienced in building small but wonderful-looking websites.
